1. Tender Form in Desired Formats:-Technical Bid and Financial Bid (Duly Signed) enclosed in a single envelope as mentioned in the Annexure-I for running college canteen.
2. Copy of challan of tender fee of Rs 100/- which is to be remitted in Govt. Treasury under MH 0202-Higher Education ,Other receipts which is non refundable.
3. Cash Deposit Receipt (CDR) amounting Rs. 10000/- (Ten Thousand only) pledged in favour of the Principal Govt. GLDM Degree College Hiranagar
1. Technical Bid and financial Bid mentioning the rate of rent for the college canteen in Annexure I duly signed by the Contractor. Incomplete, conditional & Vague tender will be out rightly rejected. (Minimum Rate per month is Rs 2200/-)
4. The Canteen Contractor must deposit advance rent of three months before its inaugural
5. The Contractor shall not sublet the contract. Subletting of Contract and unauthorised closure of canteen for more than 3 days shall invite cancellation.
6. Canteen timing shall be from 9 a.m to 3 p.m on all working days & no female workers shall be retained after 3.00 p.m. No workers shall be below the age of 14 years.
7. Contract shall be for one year from the date of allotted tender, with the option for renewal based on performance and mutual agreement.
8. The Contractor must comply with all applicable health, safety, and sanitation regulations & will be responsible for the upkeep and maintenance of the canteen premises.
9. The undersigned reserves the right to accept or reject any or all submitted tenders without assigning the reason thereof

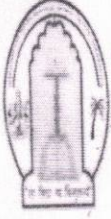

In case of successful bidder. The bidder have to submit a notarized affidavit on a stamp paper that the bidder firm has not been blacklist / debarred/ prohibited by any state / Central Government Department / Organization / Institution within period 01 week from the award of contract for running the college canteen.
3. Bidder /Firm/Agency /Contractor should have valid Trade Licence from competent authority recognized by FSSAI Act, 2006.

GENERAL INFORMATION AND INSTRUCTION

1. The Bidder /Firm / Agency /Contractor shall carefully examine the terms and conditions before submitting their tenders.
2. Within 07 working days of the award of contract by the college the successful Bidder / Firm /Agency /contractor shall be required to enter into a **formal agreement**.
3. The Principal Govt. GLDM Degree College Hiranagar reserves the right to reject any or all the tenders, either whole or in part without assigning any reasons.
4. College will provide canteen building having approx. Space 99 sq. Mts , electricity fitting and CCTV cameras whereas utensils & furniture will be arranged by the contractor. No encroachment of the surrounding area and open space will be allowed
5. The contractor should submit a detailed proposal outlining their operational plan, and staffing
6. The tender submitted by the Bidder/Firm /Agency/contractor will be opened on next working day of last date of tender submission by the college canteen committee and members of college purchase committee in the office chamber of the Principal, Govt. G.L.D.M Degree College , Hiranagar in the presence of the Tenders/ representatives who wish to remain present in the tender opening process.
7. Any dispute arising out of this shall be referred to the Administrative Department (Higher Education of J&K) Govt.), whose decision shall be final and binding upon both the parties.
8. The legal jurisdiction shall be the Hon`ble Courts of the J&K UT in District Kathua.
9. The successful Tenderer shall be responsible for running the canteen strictly in accordance with the contract and terms and condition mentioned in tender document .deviation if any, can lead to blacklisting of the contractor.
10. The successful contractor shall have to abide by the standard terms and conditions of the NIT and also as laid down in the J&K Book of Financial rules/codes and the conditions as per the contract.
11. Any other condition that is not indicated here can be incorporated in the contract.
12. The college administration reserves the right to alter the food menu as per requirement of college students during the period of contract.
